PCOE Radio Procedures

- 1. Know what you are going to say before transmitting**
- 2. Identify yourself first, then identify to whom you want to speak**
- 3. Hold down the transmit key, pause, then begin speaking**
- 4. Transmit pertinent information only – no idle chatter**
- 5. Outsiders, including media, are able to monitor transmissions**
